Annual Activity Report 2018-19:

About SNASS:

SNASS was born when a group of members of the Thappalampuliyur village community volunteered to come forward and make a concerted effort at reinducting the daily pooja and rituals at the temples in the village of Thappalampuliyur ("Village"), which had got disrupted due to lack of funds. SNASS RELIGIOUS TRUST was created on January 8, 2012 in Chennai, Tamil Nadu and registered soon after when the volunteers decided to garner the support of likeminded members of the community and devote more time and energy to the initiatives of SNASS.

Purpose:

SNASS aims to achieve its primary objective of ensuring the conduct of daily poojas and sanskars and celebrate special religious functions in the temples in the village of Thappalampuliyur. Besides, the interest, enthusiasm and the support from the members across the country which alone made the restoration and conduct of kumbabhishegam of the temples in the village, has also given the right momentum and motivation to extend this purpose to ensure maintenance of the temples by attending to essential repairs and regular upkeep.

Activities:

During the previous year, SNASS focused on the following activities:

- > Ensuring the conduct of daily pooja and other sanskars in the temples in the village of Thappalampuliyur.
- > Ensuring conduct of the important Temple celebrations.
- ➤ Bringing in unity and substantial improvements in the conduct of special occasions like Kala Arumbu, Navarathri festivals by enhanced level of participation by devotees and local villagers in the conduct of these events. During the year, Thaipoosam was also celebrated with lot of enthusiasm with Veedi Ula.
- Continuous focus on enhancing the satisfaction level of visiting out station members with the help and support of the village SNASS team and families, with improved amenities. SNASS feels that there is an infusion of better comfort and confidence levels in the minds of the devotees, leading to more active interest in the trust activities.
- ➤ Conduct of Samvastharabhishegam in both temples which were consecrated. The increasing number of visiting devotees to the temples and the village has brought immense level of satisfaction to all the members actively participating in the samithi's initiatives.

- > Set in place a smooth process for conducting pooja's on special days month-on-month in the temples which has helped draw the village community to visit the temples regularly. Noteworthy to mention here are the Pradosham, Ekadasi and Marghazhi utsavs and special parahara poojas.
- > The Annual special functions of Navarathri, Kala Arumbu, Rudrabhishegam and are taking place with good participation from devotees with families and villagers.
- As a measure of improving on bringing back the old traditional functions conducted at the temple, the "Thiruvadhirai function" was celebrated in a grand manner with 'veedi ula' of Sri Uthsava Nataraja and 'Thaipoosam' was celebrated with 'veedi ila' of Sri somaskandar. This brought lot of cheers and great of satisfaction to all the residents and devotees.
- > Similarly, Aadi pooram in 2018 was celebrated with a good participation of Women devotees at the Nithyakalyani Amman Temple.
- > Painting and patchwork was undertaken in both temples to as part of regular maintenance and the overall upkeep levels at the temples also have gone up, making the temple premises cleaner.
- ➤ The desilting of the two ponds near the two temples was taken up by the Villagers with the help of financial assistance from kind hearted donors. While the Pond near the Pillayar Koil was desilted in 2017, the Periya Kulam opposite the Nithyakalyani Amman temple was desilted in 2018. The desilting of the Mariamman Temple Pond was taken up and completed in 2019. The desilted ponds with good amount of water stored has increased the look and beauty of the temple at the back drop of these ponds.

Overall, it was a good year for SNASS wherein it was unanimously felt by all that the activities of SNASS have brought a better harmony and unity amongst the residents of the village.

Focus for the future:

- > Strengthen the support base by identifying and enrolling more members, focusing on the younger generation; SNASS hopes that the 500 strong member families will also support in these initiatives.
- > Continue the focus and work being done towards further improving the amenities and facilities for the visiting outstation devotees to make their trip to and stay at the village an enjoyable and a pleasant experience.
- > Strengthen a sense of belonging in the next generation young members and motivate them to participate and contribute to the functioning of the Trust and its activities.
- > Increase the focus and efforts for continuous upkeep and maintenance of all the temples renovated.
- Continue to work towards strengthening the financials and the human resource support for better functioning of the trust. Special focus is being given to stabilise annual contributions for the conduct of daily poojas and augmenting corpus fund collections to set up a reliable financial support for temple maintenance activities.
- ➤ Work towards spreading and popularising the "Navapuliyur Yathra" which will enhance the devotee base for the village and may also lead to improvements on many fronts in the village as a whole.
